# Title I Programs Provide Supplemental Support

The purpose of Title I, Part A is to help local educational agencies (LEAs) improve teaching and learning in high-poverty schools and help children failing or most at-risk of failing meet challenging state academic standards.

At Westcliffe, our Title I funds support:

- 1 Reduced Class Size teacher in grade 4
- After School Program for grades 2-5
- 2 Interventionists
- Classroom materials, books, and supplies
- IXL program for grades 2-5
- Professional Development for teachers
- Parent Involvement Coordinator
- Family Engagement Activities

# Who decides how funds are used?

Every school has a School Improvement Council as well as other various Parent Advisory and Stakeholder groups. The groups are made up of:

- Parents, Teachers, other Staff members, school administration
- These stakeholders provide input on how to use Title I funds



#### Parent's Right to Know

Westcliffe will provide parents, upon request and in a timely manner, information regarding the professional qualifications of the student's classroom teacher including:

- State qualification and licensing criteria for the grade and subject areas in which the teacher provides instruction.
- Teaching under emergency or other provisional status through with State qualification or licensing criteria have been waived.
- Teaching in the field of discipline in which the teacher is certified.
- Whether the child is provided services by paraprofessionals and, if so, their qualifications.

#### Parents may also request:

- Information on the level of achievement and academic growth of the student, if applicable and available, on each of the state academic assessments required under this part in ESSA.
- Timely notice that the student has been assigned, or has been taught for four or more consecutive weeks by a teacher who does not meet applicable state certification or licensure requirements at the grade level/subject area in which the teacher has been assigned.

- South Carolina's academic content standards establish high expectations for all students.


## School Improvement Plan



# Math Yearly Goals

During the 2022-2023 school year, the percentage of students (grades 3-5) Meeting/Exceeding expectations on SC Ready Math will increase from 53% to 63%.

#### **Strategies**

- Teachers will plan, model and implement intentional content specific classroom discussion ex. explain math thinking, justification of answers.
- Teachers will provide focused and deliberate practice that is standards based and driven by learning targets for daily instruction.

## ELA Yearly Goals

During the 2022-2023 school year, the percentage of students (grades 3-5) Meeting/Exceeding expectations on SC Ready ELA will increase from 40% to 48%.

#### **Strategies**

- Teachers will plan, model and implement intentional content specific classroom discussion that includes higher level thinking and open ended questions.
- Teachers will provide explicit phonics instruction and provide opportunities for repeated reading of grade level texts.
